## FAQ's

### What is the CARES Emergency Grant?

**A:** The United States Government has allocated funds to Homestead Schools for us to help our students who have an emergency situation due to the COVID-19 pandemic and the transition to going to school online. These funds are to be used for: Cost of attendance items that would affect a student's ability to remain in school. These items could be the cost of food and housing due to a loss of income, needing to overcome technology challenges to be able to continue school on line, child care challenges due to school being out of school for the remainder of the year, or other situations due to the pandemic.

### Am I eligible to receive an Emergency grant?

**A:** You must be eligible for Title IV Financial Aid.

- If you've completed a FAFSA and have received a Pell grant and/or a Direct student loan, you are likely eligible for this grant.
- If you have not completed a FAFSA, you still may complete one in order to see if you are eligible.
- If you complete a FAFSA or have completed a FAFSA and are deemed ineligible for Title IV aid, you will not be eligible for this grant.

If you are Active, on Academic Probation, or on an Approved Leave of Absence between 03/19/2020 and 06/30/2020 you may be eligible to receive the emergency grant. **Note:** If you are in a withdrawn status at the time the disbursement is being sent, then the funds will be voided and reissued to another eligible student. You are not eligible for this grant if you are enrolled in a fully online program. The U.S. Government determined this grant may only be issued to students who are attempting to transition from ground to online classes.

### What if I am scheduled to re-enter, but am currently withdrawn?

**A:** In a limited number of cases, a withdrawn student may be eligible upon re-entry if the withdraw was due to a COVID-19 issue and the school was informed of this at the time of withdraw. When you meet with financial aid to finalize your re-entry financial aid packaging, you can inquire about your eligibility for this grant.
